

RESOLUTION NUMBER 2022-17

**A RESOLUTION REVISING
CERTAIN WATER SERVICE
RATES AND FEES PURSUANT
TO ORDINANCE NO. 2022-09
OF THE TOWN OF TRINITY,
ALABAMA AND PROVIDING
AN EFFECTIVE DATE FOR
SAID REVISIONS**

WHEREAS, Ordinance No. 2022-09 of the Town of Trinity, Alabama, authorizes the Town Council to revise water service rates, fees, and charges from time to time by resolution of the Council; and

WHEREAS, the Council has determined that adjustments in certain fees and charges are necessary.

NOW, THEREFORE, be it **RESOLVED** by the Town Council that, pursuant to the said provisions of Ordinance 2022-09, the following charges shall be revised as of the effective date of January 1, 2023, hereof and charged as follows:

(A) Water Service Rates:

1. Residential:

First 2,500 gallons or less	\$ 15.72
Next 10,000 gallons	\$ 5.17
Next 20,000 gallons	\$ 4.84
Next 50,000 gallons	\$ 4.52
Next 150,000 gallons	\$ 4.00
Next 750,000 gallons	\$ 3.28
Over 750,000 gallons	\$ 2.68

2. Commercial:

First 3,000 gallons or less	\$ 20.00
Next 10,000 gallons	\$ 5.17
Next 20,000 gallons	\$ 4.84
Next 50,000 gallons	\$ 4.52
Next 150,000 gallons	\$ 4.00
Next 750,000 gallons	\$ 3.28
Over 750,000 gallons	\$ 2.68

(B) Water Tap Fees:

1. 5/8" and 3/4" meter \$ 800.00
2. 1" meter \$1,000.00
3. 2" and above actual cost
4. In instances where the Town's actual cost of installation of water taps exceed the applicable fee specified herein, the customer shall pay the actual cost to the Town in labor, materials and other expenses over and above tap fee.
5. Actual cost of installation will include costs associated with labor, materials, equipment, and any other expense associated with project.

(C) Reconnection Fees:

1. During office hours \$ 30.00
2. Non-office hours \$ 100.00

(D) Temporary Hydrant Fees \$ 50.00
