

ORDINANCE NO. 2022-09

**AN ORDINANCE REPEALING ORDINANCE NO. 2020-01
OF THE TOWN OF TRINITY, ALABAMA, BUT
PRESERVING ALL RATES, FEES, AND CHARGES
PREVIOUSLY ESTABLISHED PURSUANT TO SAID
ORDINANCE AND PROVIDING THAT ALL WATER
SERVICE-RELATED FEES, CHARGES AND RATES
SHALL BE HEREAFTER ESTABLISHED BY
RESOLUTION OF THE TOWN COUNCIL FROM TIME TO
TIME**

WHEREAS, the Town Council of the Town of Trinity, Alabama ("Council"), previously adopted Ordinance No. 2010-01, which provided that water service rates and water tap fees could be set from time to time by resolution of the Council; and

WHEREAS, the Council has by Resolutions No. 2010-02 and 2013-10 revised certain rates pursuant to said Ordinance; and

WHEREAS, the Council desires to extend the scope of said Ordinance No. 2010-01 so as to provide that all rates, fees and charges with regard to water service be set from time to time by resolution of the Council.

NOW, THEREFORE, be it **ORDAINED** by the Town Council of the Town of Trinity, Alabama, as follows, to-wit:

SECTION 1. Ordinance No. 2010-01 of the Town of Trinity, Alabama, is hereby repealed, but the repeal of said Ordinance shall not affect any rights or obligations which accrued or any action which was taken during the effective period of said Ordinance, nor shall its repeal be deemed to revive any prior water service rates, nor nullify any water service rates set pursuant to said Ordinance. All such rates which have been in effect by ordinance or resolution of the Town of Trinity, Alabama, shall remain in effect until such time as they have been revised by

resolution pursuant to this Ordinance.

SECTION 2. All fees, rates and charges for water service and related appurtenances and services shall be set from time to time by resolution of the Council. Specifically, but without limitation, those fees, charges, and rates shall include the rates charged for water service, tap fees, deposits, connection fees, reconnection fees, disconnection fees, meter costs, hydrant costs, temporary hydrant costs and all other costs relative to the provision of water service to customers within the Town of Trinity, Alabama.

SECTION 3. The effective date of this Ordinance shall be the 25th day of October 2022, following its adoption and publication according to law.
